Summary of key findings

This provision meets requirements

- The manager, who is a qualified teacher, is passionate about promoting children's learning and development. She has devised a curriculum to support this, the ethos of which is shared and promoted throughout the staff team. For example, when noticing that some children arrived at the setting with limited communication skills, she introduced storytelling and language sessions. She explains how this has promoted children's interest and eagerness to share their ideas and has extended their vocabulary.
- Staff are experienced and have been working at the setting for many years. Staff say they feel highly supported by the manager and provider, who offer constructive, professional challenge and praise for what they do well.
- Staff work exceptionally well together, deploying themselves to meet the needs of the children. They treat each other respectfully and work very well as a team. These behaviours are reflected by the children, who show equally high respect for others and excellent behaviour.
- Staff work closely with children, playing alongside them and offering praise and support. Staff show genuine interest as they listen to what children have to say. When a child shows them a model they have made, staff ask interesting questions, encouraging children to think and respond. Children are visibly proud of what they can achieve and benefit from adults who take time to appreciate their skills.
- The provider has a clear understanding of the club and knows the staff very well. He provides highly effective mentoring to staff which is targeted to their development needs. This effective oversight of the provision has a very positive impact on children. Parents report that they are confident in the service provided and share their view that the provider is highly influential.
- Staff understand how they can promote children's development within a fun and relaxed environment. They work very closely with other professionals involved in the care of children to ensure they can provide the best support.
- There are ample opportunities for children to make choices in their activities, such as choosing between making masks, playing sports and team games and looking at books together.
- Children enjoy daily opportunities to be active. Mealtimes are relaxed and chatty, where children can enjoy the company of staff and their friends as they sit together to enjoy healthy and tasty snacks.
- Staff have a clear understanding of how to keep children safe. They understand how to recognise signs that a child is at risk and know what to do to protect them. Children have a clear awareness of the rules and how to keep themselves safe.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Of these, five members of staff hold appropriate early years or play work qualifications.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- Although there were no children in the early age range present at the time of this inspection, there were children present who were over the age of five years.
- The inspector completed a learning walk with the manager and provider.
- The manager and inspector observed activities being provided for the older children and discussed how effectively they were planned and implemented.
- The inspector held a leadership and management meeting with the manager and provider.
- Older children told the inspector about their friends and what they like to do when they are at the club.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
